# Small online sharing groups - families

For this online meeting, Taizé is offering a platform for small sharing groups for parents (or legal guardians) with children between 3 and 14 years old (if other family members live in the same household, please indicate this once you have registered).

### **How it works**

- To join one of these groups, you must register via the online form and sign-up to the Users' Charter shown below.
- Registration is done by one of the parents, without each member of the family having to register individually.
- Once you have registered, we will ask you to provide us with the names and ages of the family members who will participate in the sharing so that we can form groups taking into account the whole family.
- Small sharing groups bring together between 3 and 4 families. The team that manages the platform is responsible for forming groups by language or country.
- In each group, one family is chosen by the Olinda team and has accepted the responsibility of leading the discussions.
- The sharing takes place by video conference.
- The applications chosen for the video conference are Zoom and Discord. They do not involve any sharing of personal data, telephone or email.
- It is the sole responsibility of the parents (or legal guardians) to share this personal data. Taizé will not communicate them.
- The discussions will be based on part of the "Onlineda" program (www.taize.fr/olinda): the content of the 1<sup>st</sup> day ("Noah and his lockdown in the ark") and the 4<sup>th</sup> day ("From folly to wisdom.")
- If you have not already followed the "Onlineda" program, we suggest that you go through days 1 and 4 during the weekend of the meeting. Each day includes three moments: Song (video) / Biblical presentation (videos) / sharing (file with questions and activities).

### Note

Taizé does not actively monitor exchanges and cannot be held responsible for any activity or content shared in a wrongful use of this platform. In the event of non-compliance with the Users' Charter, the participants concerned may be excluded from these shared activities.

By registering their children, parents (or legal guardians) are fully responsible for their behaviour and their respect of this charter.

## **Users' Charter**

#### Each parent (s) participating in these small sharing groups is expected to:

- Always respect the integrity and dignity of the participants, both parents and children.
- Respect other families in their integrity and identity. Every family is different from another.
- Do not include in the sharing group other people than those indicated during your registration and validated by the e-Olinda team.
- Avoid inappropriate remarks or activities that lead, even inadvertently, to mockery or humiliation.
- Make sure that each person feels welcomed also with the frailties s/he bears.
- Do not pressure anyone to reveal secrets, or anything they are uncomfortable with, during the time of sharing.
- Use appropriate language and behaviour.
- Never insist on obtaining someone's personal data.

#### Each parent(s) participating in these small sharing groups urges their family not to:

- Leave children alone in front of the screen at any time.
- Disseminate content that infringes on a person's personal, intellectual property or any other rights.
- Organise or participate in any form of bullying.
- Share material that promotes, for example, self-harm or suicide.
- Share words or images of a sexual nature.
- Share suggestive or violent material associated with minors.
- Share material with the intent to embarrass or damage the reputation of another individual.
- Use "sexting", which is considered sexual harassment under French law.
- Disseminate viruses or encourage phishing activities.
- Try to steal another user's account.
- Engage in activities considered illegal by the application used, Discord or Zoom.

## In the event of a problem
